## 2. CANCELLATION: Tipperary Irish Tours Cancellation & Refund policy

### Cancellations and Refunds

A \$500 per person nonrefundable deposit is due 11/15/18 and must accompany Booking Form and Tour Registration form.

All cancellations and requests for refund must be made in writing. The postmark of your notice of cancellation will act as the date of cancellation. Refunds will be made according to the following schedule:

#### More than 120 days Prior to Departure

A full refund, less a nonrefundable deposit of \$500 and the costs of any airline or theatre tickets purchased on individual's behalf.

#### 90-119 Days Prior to Departure

A full refund, less non refundable deposit of \$500 and the costs of any airline or theatre tickets purchased on individual's behalf, as well as penalties assessed by hotel, tour companies, and/or other suppliers.

#### Less Than 89 Days Prior to Departure

No refund

*In the event of a participant being replaced, new participant will incur all change fees*

3. **YOUR RESPONSIBILITY:** You are responsible for obtaining proper travel documents in advance of departure and presenting them at the time of check in. Proper documents required for your travel arrangements include **VALID US PASSPORT**.

4. **TRAVEL INSURANCE:** Now that you have arranged your trip, we feel that it is our responsibility as a professional travel company to recommend travel insurance to protect your investment.
